A story behind the strong women

- 1949 born in Shanghai
- 1978 she gave birth to a child
- 1987 she went to study in Japan
- 1990 she graduated and find a white collar job in Japan
- 1997 her son was successfully admitted to a famous university in Japan
- 2000 her only son was killed in a traffic accident in Japan
- 2002 she decide to fulfill a promise for her son...until now

For the last 12 years the native of Shanghai has planted different kinds of tree in Inner Mongolia trying to reforest the region, but also to keep the memory of her dead son alive

Why her?

- She planted a total of 500,000 trees on the desert in six years, the total area of afforestation has more than 5,000 acres.



Currently, she is carrying out an activity. She promotes that the mother who donates 5 RMB will plant a tree in the hopeless place.

Yi couples also donated 250,000 RMB to established a hope primary school in Hunan Province Wangcheng City

A collaborative effort of universities, civil society organizations and socially responsible companies dedicated to protecting workers' rights around the world.

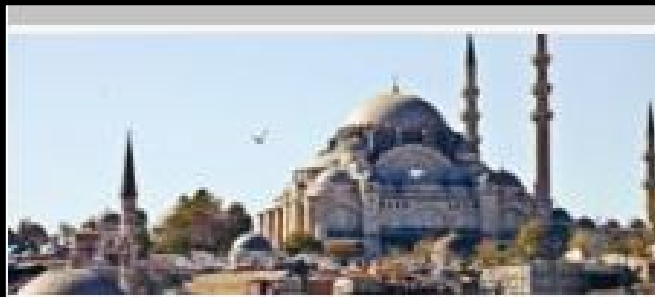

adidas works with supplier to reduce working hours for pregnant women and provide childcare facilities for children.




Preventing Discrimination Against Pregnant Women in Bangladesh
